MOTION by Ruth Spade, supported by Ronald Libey,
that the following preamble and resolution be adopted:

WHEREAS:

The undersigned are parties to a Collective Bargaining Agreement which expires on June 30, 2010 and,

The Gwinn Administrators Union and the Gwinn Area Community School Board of Education agree that:

1. All wages, salaries, and salary step increases will be frozen at the 2008-09 contract level for the 2009-10 school year, and,
2. All terms and conditions of the current Labor Agreement will be "rolled over" to the 2009-10 school year, and extended to June 30, 2010, and,
3. All terms, conditions, salaries and step increases in the Master Agreement scheduled for the 2009-10 school year shall instead be paid and in place during the 2010-11 school year.

NOW THEREFORE BE IT RESOLVED:

Understanding that all terms and conditions of the current Labor Agreement remain unchanged and in effect for the 2009-10 school year, the parties signify agreement to the above by the representative signatures appearing hereon.
